

## Miss Fannie's Friends Foster Agreement

**Please read and initial the following statements:**

\_\_\_\_\_ Foster animals are owned by Miss Fannie's Friends. If for any reason during a foster care period, you can no longer care for the fostered animal, you must contact Miss Fannie's Friends immediately and return the animal.

\_\_\_\_\_ Foster animals are to never go to your personal veterinarian for routine shots, evaluations, spay/neuter, ect. Miss Fannie's Friends works with vets that are familiar with shelter medicine. The only exception is, during an emergency, you may use your personal veterinarian, but Miss Fannie's Friends may not reimburse vet costs without prior notification and approval.

\_\_\_\_\_ Foster parents must dispense all medication as directed by the veterinarian, if needed.

\_\_\_\_\_ Miss Fannie's Friends does our best to assure each animal is healthy. But if an animal comes straight from animal services or the streets, there is a chance it has been exposed to illness. You need to understand you are taking a risk that the animal could be sick and not show signs for a few days. Therefore, we recommend to quarantine/isolate the animals from other pets for 10 days.

\_\_\_\_\_ A Miss Fannie's Friends team member will visit your home prior to fostering.

\_\_\_\_\_ You will need to commit to transporting your foster to and from at least half of scheduled adoption events. A list of events will be provided to you and are posted on Miss Fannie's Foster Facebook page. Foster parents are not required to stay for the entire adoption event.

\_\_\_\_\_ You will need to commit to transporting your foster and/or coordinating with another foster parent to transport them to PETS Low Cost Spay & Neuter Clinic for needed vaccines, testing and spay/neuter surgeries.

\_\_\_\_\_ All of Miss Fannie's Friends cats and kittens are required to be indoor pets only. Do you agree to keep your foster cats and kittens indoors at all times? If a foster parent is found to be in violation of these terms, the foster parent will be held responsible for the cost of retesting their foster for FELV and FIV at PETS clinic, \$20.

\_\_\_\_\_ I understand that if I decide to adopt an animal that I have in foster care, I must fill out an application, have it approved and pay the adoption fee.

\_\_\_\_\_ I agree I will bring no claim or action against Miss Fannie's Friends or its members, by reason of this foster. I understand that Miss Fannie's Friends shall not be liable for the animal's actions, behavior, or any possible damage done by the animal, or any result thereof, once the animal is in fosters care.

\_\_\_\_\_ I understand that Miss Fannie's Friends has the right to investigate and to remove the animal if the home is unsuitable or the terms of this contract have not been fulfilled.

I understand that this document represents a legal contract between me as the foster and Miss Fannie's Friends. I must abide by this agreement and that this agreement applies to any and all animals that I foster through Miss Fannie's Friends. By signing below, I acknowledge that the information I provided to Miss Fannie's Friends is correct to the best of my knowledge.
